- TC proposed that as we only had six nominations, per Clause 45.6, the six nominations be accepted. This was seconded by HT.

5. Members Questions and/or comments

- JS raised the point of communicating the boarding service we offer when cats are adopted. TC advised it is part of the adoption communication and a voucher for 10 percent discount is included in the adoption folder.
- HT enquired about moving venues. TC advised the Committee will discuss our options at the next committee meeting (being held after the AGM). We have a few options to consider. Our Lease at the current premises does not expire until end January 26.
- RK raised the issue of accessibility of a new venue – easily accessed by public transport. TC advised that is part of the consideration process.
- JS asked whether we would need to pay strata fees at these venues. TC advised all fee payments various from venue to venue. TC confirmed we currently pay \$55,000 pa and \$16,000 pa on top of that for strata fees.
- JS mentioned a television morning show promoting to get a pet for Christmas from a shelter as opposed to a breeder. TC commented that there are possibilities for returns after the Christmas period due to a rushed decision by buyers. We haven't seen higher returns after COVID or in Januarys.

The Chairman closed the meeting at 13:55.
